#### FORM 10 OFF-LICENCE

Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012

**PURSUANT** to the Sale and Supply of Alcohol Act 2012 (the Act), <u>MAURICE JOHN MCQUILLAN</u> (the licensee) is authorised to sell alcohol on the premises situated at 5 Boyce Street Blenheim, Marlborough District and known as "Superliquor Springlands", to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Sub part 7 of Part 2 of the Act

### CONDITIONS

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on Anzac Day
- (b) Alcohol may be sold or delivered on the following days and during the following hours:
   Sunday to Thursday
   9.00 am to 8.00 pm
  - Sunday to Thursday9.00 am to 8.00 pmFriday and Saturday9.00 am to 10.00 pm
- (c) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- (d) The licensee must implement and maintain the steps proposed in the application for the licence aimed at promoting the responsible consumption of alcohol.
- (e) The licensee, when conducting phone, mail, internet sales (remote sales) must ensure that all the requirements under Section 59 of the Act relating to remote sales are complied with.
- (f) The whole premise is designated as a supervised area

### **DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S**

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from Boyce Street is designated as the principal entrance.

### DURATION


Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -


- (a) either-
  - (i) Until the close of the period for which it was last renewed; or
- (ii) If it has never been renewed, until the close of the period of 12 months after the day it was issued; but
  (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either-

(i) until the close of the period of 3 years after the period for which it was last renewed: or (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.
